The Mediator's Toolkit: Questions to Create a Paradigm Shift in Parties and Move from Positions to Underlying Interests in Mediation with Gerry O'Sullivan

Workshop Description

Questions are a key tool in mediation: they can serve to invite self-reflection, assist parties to understand the nature and impact of their dispute. Questions can help to generate ideas, they can assist with countering information deficits and distortion or they can create a paradigm shift in the parties' thinking and approach and move them from Positions to Underlying Interests.

This is a one-day workshop based on 'The 5 Questions Model' which was developed by Gerry O'Sullivan in her book: 'The Mediator's Toolkit: Formulating and Asking Questions for Successful Outcomes', New Society Publishing, Canada. It is designed to radically sharpen, focus, and improve questioning skills to help mediators facilitate parties to come to successful and sustainable mediation settlement agreements.

In this MiKK Workshop Gerry will deliver the theory behind a question type using motion graphic presentations, as well as film footage of a role-played mediation. This will be interspersed with questions and discussions. Participants will take part in small group exercises and roleplays to explore and embed their learning. The filmed roleplays show cases from workplace and civil and commercial mediation, but the learning is adaptable to any mediation sector.

It would be helpful for you, but not essential, to have a copy of 'The Mediator's Toolkit: Formulating and Asking Questions for Successful Outcomes' with you.

Gerry O'Sullivan has 35 years' experience in conflict and mediation work, training design and delivery and team/group facilitation. She has written and published a book titled: 'The Mediator's Toolkit: Formulating and Asking Questions for Successful Outcomes', published by New Society Publishers, Canada. Gerry has developed training materials to accompany this book, including filmed roleplay demonstrations of some of the questions that can create a paradigm shift in the thinking of parties.


Generic Training and Evaluation of Training Interventions

WS 2: Saturday, 20th November 2021

Mediating on Screen: Taking Stock of the Dos and Don'ts of Online Mediation with Prof. Dr. Lin Adrian

Workshop Description

Thanks to the surge in video-supported mediation in all arenas during the pandemic, today we know much more about online mediation than we did a few years back. This makes the timing perfect for taking stock of the dos and don'ts when mediating on screen – also in the area of cross-border mediation where online mediation has been performed for years.

To some extent, in-person mediation methodologies can be adjusted to fit the screen reality but virtual mediators also need to develop new practices. In the workshop, we will discuss how to best set the virtual scene, how to adjust the mediation process, how to establish and maintain interpersonal contact and how to enhance online communication. We will draw on communication theories, on recent literature and research, and on the experience of the participants in jointly approaching the best up-to-date practices of video supported mediation.

The session will be hands-on and interactive. There will be presentations, discussions and on-line exercises, so please bring a laptop and headphones to the session.

Prof. Dr. Lin Adrian, Mediator, JD, Ph.D. and MS, University of Copenhagen

Lin Adrian is associate professor of mediation at the Faculty of Law, University of Copenhagen. She is director of the Faculty's executive, postgraduate and interdisciplinary Master in Mediation and Conflict Resolution. In addition to teaching at the university, she teaches at other universities in Denmark and abroad. She also teaches and trains practitioners as well as speaks on mediation in private companies, organizations, NGOs, government institutions. She has lived in four countries and spoken on mediation in among others Germany, France, the US, Norway and Lithuania. Furthermore, she is a practicing mediator in primarily workplace, business and family disputes. Lin's main area of research is alternative and online dispute resolution. She has published numerous articles and book chapters on mediation and other dispute resolution processes, including online

dispute resolution, edited three books and authored two book, one of which is a handbook on mediation for practitioners.



WS 3: Sunday, 21st November 2021

Child Abduction: The Long-Term Effects with Prof. Marilyn Freeman

Workshop Description

The long-term effects of child abduction can be seriously detrimental to previously abducted children who often struggle throughout their lives to understand why they feel the way that they do about themselves and their relationships. Those issues, and what can be done about them, are similarly not generally well known or understood by the adults involved in the abduction event, or many of the professionals who come into contact with them. Most parents, however, do want to do the right thing for their children. Mediation with informed, skilled, specialist practitioners provides an extremely important opportunity to raise awareness and address with the parties the likely impact on the child of continued conflict between the adults involved in an abduction situation. This insight may encourage their ability and willingness to find a consensual way forward to their dispute.

The MiKK 'long-term effects of abduction' workshop will fall into two parts: the first will focus on the presenter's research into abduction looking at the effects, including the long-term effects, on the left-behind parent, the abducting parent, the wider family and, most importantly, the abducted child. The second part of the workshop will centre around some constructed abduction-based scenarios which will allow discussion between the group about the situations outlined in them, and an exchange of ideas about what could be done within a mediation context to improve the outcomes for those involved.

Prof. Marilyn Freeman



Prof. Marilyn Freeman is Co-Director of the International Centre for Family Law, Policy and Practice (ICFLPP), Principal Research Fellow at The Westminster Law School, London, and chairperson of the International Association of Child Law Researchers (IACLaR). She is widely acknowledged as a leading expert in the area of international child abduction and international children's law, and publishes widely in her areas of expertise. Her current research focuses on children's participation in proceedings affecting their lives including those relating to child abduction under the 1980 Hague Convention. She has undertaken several key research projects including those investigating:

The Long-Term Effects of International Child Abduction, and The Outcomes for Children who Object to Return under the 1980 Hague Child Abduction Convention. She holds a door tenancy at 4 Paper Buildings, a

specialist Family Law set of barristers' chambers in London, and qualified as a Family Mediator, trained to undertake direct consultation with children, cases involving international child abduction and other international family disputes.
